 - Check on spring on tennis courts door to make sure working properly. Adam to check.
 - We now have an enclosure for the trash bins at the clubhouse.
 - Erica to ask Beth what is the best vines/plants for natural cover to help look better?
 - What is best way to put trash bins back in? We need to put down pavers underneath and along side the door-side of the clubhouse so we have a paved path all the way back so that it's level and does not get muddy. Get garbage in and out easier.
Put wheels up against the club house would give enough room to swivel each cart around. Flat surface will help. Have Joe come in and look at putting in this.

 - New bid plan of action was putting in topsoil, matting, grass down the hill and install rip/raff at slope behind the pool. Pipes around the playground area to run-off. Between playground and tennis court do

pipe and drain boxes to run-off. Adam – get the contractor to provide images of how it looks. Also, where the pipes would actually be run and which ditch specifically. Drain boxes are between tennis court and little area near basketball goal. Show this on the map if they can.
